Barbara Hunter Schultz has been a private pilot since 1978 and lives with her husband on their own airport near Lancaster, CA. Her first airplane was a 1950 Cessna 140A, which they still have along with a Beech 18 and several others. She is a member of the Ninety-Nines (an International Association of women pilots), International Women's Air and Space Museum, EAA (Experimental Aviation Association), and WAI (Women in Aviation). She has written "Pancho, The Biography of Florence Lowe Barnes", "Flying Carpets, Flying Wings" (a biography about Moye W. Stephens, his friends, and his achievements in aviation), and Wedell-Williams Air Service (a book on Jimmy Wedell and his aircraft). She also has written an article for the American Aviation Historical Society Journal on Elizabeth Ulysses Grant McQueen, once dubbed "the arch godmother of aviation".



Barbara's research and writings involve significant contributors to aviation who she feels should have their stories told. She was fortunate to be able to interview pioneering aviators, peruse their photos, and hear their stories. She feels that "to be significant, aviation history must include every facet and individual who became a part of flight".

Her presentation on February 1<sup>st</sup> will be on "Pancho Barnes". To quote the introduction in her book on "Pancho", "Every now and then, the human race produces unique, one-of-a-kind characters who become our celebrities, mentors, and the stuff from which legends are born. Florence Lowe "Pancho" Barnes was a character among characters. Born at the dawn of the twentieth century, she inherited wealth, status, and privilege from a family overflowing with visionaries, artists, and inventors. They endowed her with a keen intellect, spontaneity, and an insatiable appetite for adventure. As a result, Pancho never passed up an opportunity due to indecision nor did she ever hesitate to voice her opinions. She lived in a world of direct action with little room for rules or conformity."

*From the Airports Manager*

Several pilots called me during our last snowstorm and cold snap asking when the runway would be plowed and if the County was going to plow the private taxiways. I thought it would be good to let the members of the PMLAA know what the current airport procedure is for plowing at the airports.

First, the Airports Division has only one plow which gets mounted on our 4 wheel drive Dodge Pick-up truck. In order to plow effectively we install studded winter snow tires so that the truck gets plenty of traction while pushing snow. We watch the weather predictions and do our best to anticipate the need to plow. Thus we are limited by having only one plow truck but two airports. As you can guess having the Community Resources Agency's plow trucks help us out is not an option because there are many roads in the County that need to be plowed and that is their primary responsibility.

As most of you know, the main Airports office is located at Columbia Airport because Columbia Airport is much larger than Pine Mountain Lake Airport. Columbia Airport's paved runway is 4,670' long where the PML Airport runway is only 3,625' long. Also, with two aircraft maintenance facilities, a flight school, and a fixed wing charter service, Columbia Airport sees more aircraft operations than the PML Airport. If there is snow that needs to be plowed at both airports, it is advantageous and most efficient to plow Columbia Airport first and then plow the PML Airport.

We will generally wait for it to stop snowing prior to plowing. There are two reasons for this. First, for safety it is undesirable to have a plow on the runway in limited visibility and, second, we prefer to plow only once and waiting until the snow has stopped falling reduces the chance that we will have to plow a second time.

At PML Airport the approach is to only plow the runway and the south parallel taxiway. The south parallel taxiway has been identified as the County maintained taxiway because the south side taxiway runs the full length of the runway and accesses the run-up area where the north side taxiway does not access the approach end of Runway 27 nor does it have a run-up area. Plowing of the ramp area does not occur because of the existence of tiedown chains and the desire to not put a berm of snow in front of any plane in the tiedown area, especially a transient airplane. Plowing the private loop taxiway is not done because this is entirely on private property.

### **President Lynne Orloff**



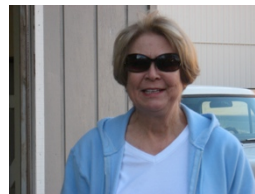
